Desirable experience: Candidates having experience in Finance, Accounts & Audit. Job Description: As per the Statutes of the University, the Finance Officer shall exercise general supervision over the funds of the University and shall advice it as regards its financial policy and perform such other functions as assigned to him/her by the Executive Council as may be prescribed in the University Act, Statutes, Ordinances and Rules. Further, Finance Officer will also perform such of the duties as have been specified in the University Act, Statutes, Ordinances, Rules and Regulations as may be required by the Statutory Bodies, Vice-Chancellor and Rectors.

General Conditions:

- 1. These positions are on deputation, officers working in higher pay level than the advertised positions may also be considered.
- 2. The Candidate is expected to have at least an overall grading of "Very Good" in the past five APARs/ACRs starting from 2018-19. The applicants may submit their applications through proper channel before last date and may also submit advance copies. However, at the time of interview applicants will have to submit the No Objection Certificate/ Vigilance clearance from their employer.
- 3. Appointments shall be made on a deputation basis, initially for a period of three years following the Government of India rules for deputation /foreign service appointments.
- 4. On-campus accommodation and medical facilities are available.
- 5. The incumbent will not have any legal right to claim regularization/appointment by absorption or any other form of further engagement upon completion of the deputation.

- 6. Fulfilling qualifying norms does not entail a call for an interview. Only candidates shortlisted on the basis of better qualification and quality of relevant experience will be called for the presentation and if shortlisted will be called for interview.
- 7. Selection will be based on the interview, and only the shortlisted candidates will be informed well in advance of the interview's date, time and mode.
- 8. Outstation candidates called for interview will be reimbursed travel expenses (up to economy class air fare) from the place of residence to Varanasi and back, as per instructions in the call letter, on the production of tickets.
- 9. No interim correspondence will be entertained.
- 10. Any form of canvassing will lead to automatic disqualification.
- 11. The University reserves the right to reject any or all applications without assigning any reasons. The University reserves the right to waive/relax any conditions.
