**Subject:** Amendment to Statute 4(1) of the Statutes of the Banaras Hindu University Act, 1915.

Dear Sir/Madam,

I am directed to inform you that the President of India in his capacity as the Visitor of Banaras Hindu University, in exercise of the powers conferred upon him by Section 17(4) of the Banaras Hindu University Act 1915 has been pleased to approve the Amendment to Statute 4(1) of the BHU relating to the service conditions of the Registrar as resolved by the Executive Council of BHU vide its resolution No.212, dated 2<sup>nd</sup> Nov.2010.

Accordingly, the Statute 4(1) of the Banaras Hindu University has been amended to be read as under :-

- 4(1) I.** *The Registrar shall be appointed by the Executive Council on the recommendation of a Selection Committee constituted for the purpose and shall be a whole time salaried officer of the University.*
- II.** *He shall be appointed for a term of five years and shall be eligible for re-appointment for a second term.*
- III.** *Notwithstanding his term of appointment/re-appointment, the Registrar shall retire at the age of 62 years or as amended by the UGC/MHRD from time to time.*
- IV.** *The qualification for the post of Registrar shall be as prescribed by the UGC/MHRD from time to time.*
